

THE ODISHA MINISTERS' DRAWAL OF SITTING ALLOWANCE RULES, 1995.

NOTIFICATION

The 13th October 1995

No 5587– OLA/2-19/95-P.A.D.---In exercise of the powers conferred by sub-section (1) of Section 10 of the Odisha Ministers' Salaries and Allowances Act, 1952 (Odisha Act 26 of 1952), the State Government hereby make the following Rules, namely :--

1. (1) *Short title* -- These rules may be called the Odisha Ministers' Drawal of Sitting Allowance Rules, 1995.

(2) *Commencement*—These rules shall be deemed to have come into force with effect from the 1st day of August, 1995.

2. *Definition*---In these rules, unless the context otherwise require :--

- (a) "Act" means the Odisha Ministers' Salaries and Allowances Act, 1952.
- (b) "Assembly" means the Odisha Legislative Assembly.
- (c) "House" means the Odisha Legislative Assembly.
- (d) "Ministers" means the Members of the Council of Ministers, by whatever name called including a Deputy Minister.
- (e) "Sitting Allowance" means the allowance admissible to a Minister for attending the sittings of the Assembly.
- (f) "Secretary" means the Secretary of the Odisha Legislative Assembly and includes any person for the time being performing the duties of the Secretary.

3. There shall be paid to each Minister a Sitting Allowance, for attending the Assembly, of Rupees one hundred and fifty per day of sitting of the Odisha Legislative Assembly.

4. Where a Minister remains absent for a consecutive period not exceeding three days, he shall be entitled to half-day sitting allowance for each day of absence and shall not be entitled to any sitting allowance, if he remains absent for more than three days consecutively for those days of absence.

5. The Ministers shall draw their sitting allowance in the same manner as they draw their salaries.

6. (1) A register shall be maintained for recording attendance of Ministers during the period in which the House is in Session.

(2) Every Minister shall be required by the Secretary to sign in the register in token of the attendance in the sitting of the Assembly during its session.

7. The Secretary shall be the authorised Officer to furnish a certificate of attendance of the Ministers to the Parliamentary Affairs Department at the end of every Assembly Session for drawal of Sitting Allowance in Form I.
