**S.R.O. No.....-** In exercise of the powers conferred by clause (d) of sub-section (2) of Section 7 of the Orissa Legislative Assembly Members' Salary, Allowances and Pension Act, 1954 (Orissa Act 19 of 1954), the State Government do hereby make the following rules further to amend the Leader of the Opposition of the Orissa Legislative Assembly's Staff and Privileges Rules, 1968, namely :-

1. (1) These rules may be called the Leader of the Opposition of the Orissa Legislative Assembly's Staff and Privileges (Amendment) Rules, 2011.


(2) They shall be deemed to have come into force on the 1<sup>st</sup> day of June, 2009.

2. In the Leader of the Opposition of the Orissa Legislative Assembly's Staff and Privileges Rules, 1968, in rule 4, -

(i) in clause (g), for the figures "9,000", the figures "₹24,000" shall be substituted; and

(ii) in clause (h), for the figures "3,000", the figures "₹10,000" shall be substituted.
