**Bhubaneswar, Dated the 8<sup>th</sup> June, 2011.**

**S.R.O. No. ....** – In exercise of the powers conferred by sub-section (I) of section 10 of the Orissa Legislative Assembly Deputy Speaker's Salaries and Allowances Act, 1959 (Orissa Act 25 of 1959), the State Government hereby make the following rules further to amend the Orissa Legislative Assembly Deputy Speaker's Motor Car Advance Rules, 1968, namely :-

1. (1) These rules may be called the Orissa Legislative Assembly Deputy Speaker's Motor Car Advance (Amendment) Rules, 2011.

(2) They shall be deemed to have come into force on the 1<sup>st</sup> day of June, 2009.

2. In the Orissa Legislative Assembly Deputy Speaker's Motor Car Advance Rules, 1968 (hereinafter referred to as the said rules), for rule 5, the following rule shall be substituted, namely :—

“5. Maximum amount of advance – the amount which may be advanced to the Deputy Speaker for the purchase of a motor car shall not exceed rupees three lakhs.”

3. In the said rules, in rule 6, for the words “the advance shall bear interest at the same rate as in the case of advances for the purchase of conveyances made to Government Servants”, the words and figures “The advance shall bear interest @ 8% per annum for the purchase of conveyances” shall be substituted.
