 5. When the people of Odisha had voted my Government to power, it was confronted by a serious financial crisis, a

negative Rs.370 Crores of opening balance and an estimated

budget deficit of Rs.1,400 Crores. Probably no Government would have faced such a precarious financial position at the start of its innings. But we remained unfazed and determined to change the face of financial position of the State to fulfill our promise of ushering in inclusive and balanced development of our State and I am proud to emphasize in this august House that we achieved what we set out to accomplish and I must thank the people of Odisha for continuously supporting my Government's actions.

the 11th Plan at 2004-05 prices. The high growth rate witnessed is here to stay, as it is estimated that Odisha's economy would register an average growth of 9% even during the 12th Plan period. The real per capita income in Odisha at 2004-05 prices has increased from Rs.14,862 in 1999-2000

6. My Government has made remarkable accomplishments in accelerating economic growth and reducing poverty. Our State recorded an average annual growth of 8.23% during

to Rs.26,900 in 2011-12, an increase of over 77% during the period. Our State achieved the highest reduction in poverty among all Indian States when the ratio dropped by 24.6 percentage points.

7. Fiscal reforms undertaken by my Government which included expenditure rationalization and revenue generation

- measures has resulted in a major turnaround of the State's Finances. I am happy to mention that the State's Finances are now robust enough to provide adequate resource support to various developmental activities of the State. I am proud to state that Odisha's Plan size which was Rs.2,484 Crores in 1999-2000 has increased to Rs.21,467 Crores in 2013-14
- 2014-15. Capital Outlay in 1999-2000 was only Rs.799 Crores. This has gone up to Rs.7,840.13 Crores in 2013-14.
 8. My Government have been able to reduce the net debt stock from 46.48% of GSDP in 2001-02 to 17.87% of GSDP

and is likely to rise to Rs.27,000 Crores for the year

- stock from 46.48% of GSDP in 2001-02 to 17.87% of GSDP in 2011-12, thereby achieving the desired level of Debt-GSDP ratio of 25% recommended by 13th Finance Commission. With improvement in fiscal situation, the State Government
- With improvement in fiscal situation, the State Government has not resorted to Open Market Borrowing since 2005-06. Contribution of State's own revenue has been improving consistently and its share in the total revenue has increased from 41% in 1999-2000 to 52.60% in 2012-13.

Odisha, the Western Odisha Development Council (WODC) has been constituted. It is dedicated to programmes under key sectors like roads, communication, agriculture, minor

irrigation, Lift Irrigation, water supply, Infrastructure development for schools & colleges, health services, electrification of villages and so on. So far 16,847 projects at a cost of Rs.770.78 Crores have been taken up and I am happy to inform you that my Government has already

completed 11,878 projects.

- **18.** The super cyclone "Phailin" that struck Odisha Coast in the month of October 2013 was one of the fiercest in India in the last 14 years. It had the potential to wreak colossal damage to human life. In hindsight it gives me immense satisfaction to say that our preparedness aided by accurate meteorological forecast helped us save millions of lives apart
- from significantly containing consequential damage.

 19. Mass evacuation in unprecedented scale to shelter homes by the administration did the job for us. While about 9,000 people perished in the last super cyclone of 1999, we sould limit loss of human lives to just 24 this time. Odished
- could limit loss of human lives to just 21 this time. Odisha Disaster Management Authority and its personnel deserve commendation for their nimbleness and the professionalism displayed during pre and post cyclone disaster management.
- **20.** My Government's efforts have been widely appreciated. Special Representative of UN Secretary General personally flew down to Odisha to felicitate our Government's efforts to
- evacuate nearly a million people ahead of the severe tropical storm. "Odisha is the first State to receive such award from United Nation in the entire South East Asia" and its response is being used as a model for other States and nations when
- it comes to handle natural disasters of such massive scale.

 21. The National Disaster Management Authority (NDMA)

has sanctioned Rs.915 Crores for Odisha to deal with natural

Realizing the importance of agriculture in the socioeconomic development of the State, my Government has taken the noble initiative of bringing out an exclusive budget on agriculture. My Government has been giving priority to the development of the Agricultural Sector through a number of measures for the benefit of the farming community of the

 23. My State is the second State in our country to present a separate budget for agriculture and allied sectors. The
- allocation for agriculture and allied sectors in this Budget has been substantially enhanced from Rs.5627.87 Crores in 2012-13 to Rs.7161.84 Crores in 2013-14. The step up in provision in the sector is more than 27%.
- 24. My Government has always remained committed to raising the socio-economic condition of our farming community as we are aware that a capable, knowledgeable
- farming base will have a strong multiplier effect on the economy. Accordingly, my Government has taken up a slew of interventions aimed at bringing about visible changes in the farming community such as the introduction of free health insurance scheme named Biju Krushak Kalyan Yojna (BKKY) to farmers and landless farm laborers that covers 5 persons

25. Access to credit at right time, for right amount and at affordable rates has always been a major handicap for our farmers. In order to make farm credit affordable, my Government is extending short term farm credit at the lowest

ever interest rate of 2% to farmers of our State through co-operative banks and commercial banks. To encourage financial discipline among the farmers, my Government is extending a rebate in interest rate of 3% on the outstanding loan with additional 2% reduction to timely settlement of the loan. To promote long term financing of agriculture activities, the State Government has completely waived Stamp Duty

- **34.** My Government has developed an ambitious plan to sink 25,000 borewells, construct 6,000 check dams, complete 39 megalift projects and install 1,000 LIPs in the coming days apart from ongoing major, medium & minor irrigation projects
- that would create additional irrigation potential of 109 thousand hectares in our State.

 35. I am happy to mention that by end of December 2013, the District Central Cooperative Banks have organized
- 76,737 Self Help Groups (SHGs) and have credit linked 61,816 Groups by providing loan to the extent of Rs.287.20 Crores. Of the total SHGs 72,787 are women SHGs with credit linkage of Rs.271.20. Further, 9541 Tenant Farmers Groups (TFGs) and 47,814 Joint Liability Groups (JLGs) have
- been formed of which 8,329 TFGs and 46,645 JLGs have been credit linked and provided with loans amounting to Rs.51.67 lakh and Rs.200.09 lakh respectively. **36.** As all of us are aware that the key parameter that
- **36.** As all of us are aware that the key parameter that determines as well as sustains societal wellbeing is the status of women in a society, particularly the condition of children growing up in that society. Holistic development of women and children in all its facets i.e. physical wellbeing, economic empowerment, political freedom and a capacity to participate

The beneficiaries receive a total incentive of Rs 5,000 spread over four installments, which is transferred directly to their accounts. About 20 lakh such persons are getting benefit from the Scheme in Odisha today. The pension amount goes upto Rs 500 per month once the beneficiary attains the age of 80 years. Further, all pensioners get Rs 200 and Rs 100 respectively once a year towards winter and summer assistance.

 39. Economic empowerment of women, a basic need to a healthy society is a prime focus of my Government. Through Mission Shakti, the flagship program aimed at women's empowerment, my Government is encouraging and motivating women to form Self Help Groups, linking them to bank accounts, promoting a culture of saving and motivating

40. To secure the nutritional needs of pregnant and lactating mothers and children below three years, my Government has at its own cost extended the Supplementary Nutrition Programme to the remaining 15 districts that are not covered

- **46.** The Government of Odisha has adopted multi-pronged approach to the development of S.T. and S.C. population who together constitute about half the population of Odisha. On the one hand, my Government has been creating an environment for educational upliftment of the community, on the other it is extending every kind of support and assistance to the S.C. and S.T. communities to escape out of the vicious
- **47.** To remove the stigma normally associated with intercaste marriages, especially when it involves a member from S.C./S.T. community, my Government introduced a cash

incentive, which has now been increased to Rs.50,000/-.

52. Under the Odisha Tribal Empowerment and livelihoods Programme (OTELP), food security to 57,000 tribal families in seven most backward districts of the State has been ensured in 35 micro-watershed projects. Of these families, 77% can now access safe drinking water within 100 meters

with 11% of country's water resources and considering the contribution made by fishermen and the potential contribution they can make to our economy, my Government has always accorded priority to the upliftment and empowerment of this important community. A robust fishery sector not only enhances rural income levels but also creates huge

employment opportunities and earns precious foreign exchange.

54. To encourage fish farming, my Government is providing an interest subvention upto 5% for a loan amount of Rs.3 lakh. To inculcate prudence and discipline among the lonees, an incentive in terms of reduced interest rate of 2% is offered to farmers, so that credit is not denied in future because of earlier default. Already 12,000 farmers have availed such loans so far and as a boost to encourage long term investments in this sector; my Government is offering a concessional interest rate of 3% for a loan upto Rs.10 lakhs with an additional incentive of 2% rebate on interest rate for

fish farmers, my Government is extending a one-time financial assistance between Rs.3,000 to Rs.7,500 per student who have scored 50% and above in Matriculation examination.

- 56. To encourage integrated fish farming and raising of quality fingerlings, my Government is offering 30% waiver to all loans available under various schemes to interested farmers.57. Fish farming at times exposes the farmers to health
- hazards. It is equally applicable to fisher folk venturing into deep seas. As a humanitarian gesture and to provide succor and assistance in times of their specific needs, my Government extends an assistance of Rs.50, 000 for treatment of some of these diseases. An additional Rs.5,000/- is given to sea faring fishermen who develop
- **58.** Our State has been proudly receiving National award "Golden Peacock" continuously for the last three years for coverage of highest number of fishermen in Group Accident Insurance Scheme. 10 lakh fishermen have already been covered under the insurance scheme and another 11 lakh

- 62. Odisha's handloom sector has a rich legacy of some of
- the finest designs and patterns that are highly popular in our country and abroad. Our weavers, the repository of such traditional knowledge and skills have been neglected for years raising fears of extinction of some of these skills. My
- Government recognizes their contribution to our rich culture and has come forward to extend all possible help. It gives me satisfaction to state that 50,000 weavers' families have been brought under Health Insurance cover and of these, 35,000 families are covered under Life Insurance India's Janshree Scheme, free of cost. Further 15,000 women silk
- Scheme.

 63. My Government is providing Solar Lantern through OREDA to every weaver family. 11,000 Tassar farmer have
